

B-1 Vehicle Seating Position

ACheck the vehicle owner's manual for more information about air bag/child restraint use.

▲For vehicles without a back seat, refer to your vehicle owner's manual.

B-2 Installation in Vehicle

▲Check the vehicle belt before each use. Use only if the belt can be tightened properly and securely.

▲This child restraint should be securely belted in the vehicle even when not in use. In a crash or sudden stop, an unsecured child restraint could injure occupants.

▲Do not use a child restraint that has been in a crash. You must get a new child restraint.

B-3 Child Restraint Use

ANever take your child out of the child restraint while the vehicle is moving. Never leave child unattended.

APlacing your child in a hot child restraint may result in burns.

ADo not use a child restraint with damaged or missing parts.

▲Do not substitute parts or try to modify the child restraint in any way.

▲Do not use any child restraint accessory except those approved by Dorel Juvenile Group.

ANever allow any child to play with this child restraint; it is not a toy.

If your seat pad has a machine washable tag:

Machine wash separately with cold water on a gentle cycle. Tumble dry separately for 10-12 minutes on low heat. Remove immediately.

If your seat pad does not have a machine washable tag:

Hand wash pad with warm sudsy water, rinse clean and air dry.

Do not use bleach or use other harsh cleaners. Do not dry clean.

Replacing Pad

Slip pad over the armrests and around the back of the shell. Pull pad over the front of the seat.

D-1 Understanding Your Vehicle

Your vehicle's features may be considerably different than those pictured here. Consult your vehicle owner's manual to help identify your vehicle's specific features and locations.



D-2 Vehicle Seating Position

Some seating positions in your vehicle may not be safe for this child restraint. Some vehicles do not have a seating position that can be used safely with this child restraint. If you are not sure where to place the child restraint in your vehicle, consult your vehicle owner's manual or contact Dorel Juvenile Group Consumer Care Department.





Children are safer when properly restrained

in rear seating positions than in the front seating positions.

According to National Highway **Traffic Safety Administration** information, children in rear seating positions are statistically safer, whether you have air bags, advanced air bags, or no air bags at all.

To avoid your child being seriously burned, take the following precautions:

1. Park in the shade or where sun does not directly hit the child restraint. 2. Always use the child restraint with the seat pad.

D-3 Knowing Your Vehicle Belts

Review your vehicle's owner manual for vehicle seat belt use with child restraints. This is your best source for information concerning your vehicle.

There are some vehicle belts that will not work with a child restraint or will require special attention. You must determine if your vehicles belts are compatible with this child restraint. To help determine this, review below.

Vehicle Belts

You MUST have a vehicle lap and shoulder belt to install this child restraint.

 Do Not Use vehicle belts in center of the door or side panel

E-2 Installing Booster Using the Lap and Shoulder Belts



1. Place Belt-Positioning Booster Seat Forward-Facing in Vehicle E. Belt-Positioning Booster Use

Center the booster seat

in the chosen seating position. The back of the booster seat should be flat against the vehicle seat back.



2. Place Child in Seat

Child should sit with its back flat against the vehicle seat and bottom flat against the seat base.

3. Buckle Lap and Shoulder Belt

> Route lap portion of the lap/shoulder belt under both armrest. The shoulder belt MUST go OVER the armrest on the vehicle buckle side.

Lap belt should cross the child's thighs.



a. The shoulder belt should lay snugly across the center of the child's shoulders and across the chest (not on the face or neck).

Pull up on the shoulder belt to tighten.

Check periodically to ensure you child has not moved out of position and loosened the shoulder belt.



A WARNING:

Use only the vehicle's lap and shoulder belt system when restraining the child in this beltpositioning booster seat.

Do Not Use only the lap belt when úsing this seat as a beltpositioning booster.

The shoulder belt must always be adjusted snugly across the child's chest.
